

AN ORDINANCE AMENDING CHAPTER 5 OF BUSINESS REGULATIONS OF ORDINANCE 101 AS AMENDED BY ORDINANCE 86-2 PERTAINING TO ALCOHOLIC BEVERAGES AND PROVIDING FOR A SPECIAL SUNDAY EVENT ALCOHOLIC BEVERAGE PERMIT.

BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF TURTLE LAKE, NORTH DAKOTA AS FOLLOWS:

SECTION 1. That section of 5.0416 Article 4 of Chapter 5 of Ordinance 101 as amended by Ordinance 86-2 shall be amended to read as follows:  
Section 5.0416 Hours and Time of Sale

1. Except as permitted by Sections 5-02-05.1 and 5-02-05.2 of the North Dakota Century Code, and this ordinance, no intoxicating liquor may be sold on the licensed premises after 12:45 a.m. on Sundays; before 8:00 a.m. on Mondays; between the hours of 12:45 a.m. and 8:00 a.m. on all other days of the week; days when sales are prohibited by state Law, and on the day of any statewide special, primary or general election between 12:45 a.m. and one hour after the poles have closed. Those premises licensed with on-sale beer and on-sale wine licenses only may begin to sell intoxicating liquor after 5:00 p.m.
2. Sales of liquor shall cease at 12:45 a.m. and 15 minutes thereafter shall be permitted for customers to consume such liquor as they have purchased before the hour of 12:45 a.m. All customers must leave the premises by the hour of 1:00 a.m.
3. Between the hours of 1:00 a.m. and 8:00 a.m. of each day the doors of the establishment must be locked, provided, however, that the licensee and his employees may be permitted to enter upon the premises during such time, but no sales of liquor shall be made and no person other than the licensee and his employees may enter during said time.

Section 2. Special Sunday Event Alcoholic Beverage Permit.

1. A special Sunday event alcoholic beverage permit may be issued to a City of Turtle Lake licensed retail liquor establishment. The authority to issue a special permit rests solely in the discretion of the Board of City Commissioners. The permit shall be effective for one Sunday only.
2. A special permit may be granted only upon proper application to and approval by the Board of City Commissioners. The application for a special Sunday event alcoholic beverage permit must be made in writing and accompanied by a fee of \$20.00.
3. Under the special permit the distribution of alcoholic beverages shall be permitted between the hours of 12:00 noon on the specified Sunday and 12:45 a.m. on Monday, unless otherwise prohibited by city ordinance. All customers must leave the premises by the hour of 1:00 a.m. The general public may be permitted to participate in the consumption of alcoholic beverages distributed under the authority and

conditions of the special permit. The permit applicant shall enforce the requirements of this section and any other conditions established by the Board of City Commissioners under the permit.

Section 3. All ordinances and parts of ordinances and resolutions in conflict herewith are hereby repealed in so far as the conflicting portions thereof are concerned.

Section 4. This ordinance shall take effect and will be in full force upon date of passage.
